Description of task

This offer to tender is a quote for snow removal and de-icing on the sidewalk approximately \pm .62 KM located along Route 105 in Kazabazua, for the winter period 2021-2023 possibility of renewal for 2023-2024.

Contractor's Function description:

- Snow removal and de-icing of the sidewalks, when necessary.
- Snow removal must be done at every storm or when there is an accumulation of snow of at least 5 centimetres on the sidewalk.
- The abrasive must be applied over the entire sidewalk - \pm .62 km to ensure the safety of pedestrians at all times.
- The contractor must provide their equipment, material and abrasive. The contractor is also responsible for damages done by their equipment.
- The applicant must provide proof of liability insurance with a minimum coverage of \$1,000,000.
- The contract is for a period of two (2) years and renewable for an additional period of one (1) year at the sole discretion of the municipality
- All interested contractors are invited to inspect this sidewalk before submitting their bid.
- The contract price is in Canadian dollars and includes the Goods and Services Tax (GST) and the Quebec Sales Tax (QST).

Following the analysis of the tenders, the decision on the granting will be made by resolution at the regular council meeting, Tuesday, November 16, 2021, at the Community center located at 26, Begley Road in Kazabazua, starting at 7:00 pm

Instructions to the tenders


The bid form must be signed by the authorized person under a resolution of the board of directors of the company or a valid signing authorization document from the partners, in the case of a corporation. This resolution or this document must be attached to the bid; however, it is not required where the tenderer is a natural person acting alone and who has his own contractual liability.

The Municipality does not undertake to accept the lowest bid or any of the bids received, and accepts no responsibility for any of the bidders if all bids are rejected.
