MANDATE TO A SURVEYOR, AN APPRAISER AND OUR ATTORNEY - EXPROPRIATION LOT NUMBER 5 497 608

WHEREAS on April 21, 2022, the Municipality received confirmation from the MRC de la Vallée-de-la-Gatineau (MRCVG), through its Fonds Régions et Ruralité volet 2 program, that it has authorized financial assistance in the amount of \$55,683;

WHEREAS the Municipality is the owner of lots 5 497 613 and 5 497 614 and on March 23, 2023, received authorization from the Commission de protection du territoire agricole du Québec, file number 437751, to use these lots for purposes other than agriculture, namely for the development of a parking area and a municipal park, with an approximate area of 1,527 square metres, corresponding to lots 5 497 613 and 5 497 614 of the cadastre of Québec, registration division of Gatineau:

WHEREAS one of the objectives is to ensure the safety of Gatineau River users by supporting public infrastructure projects with good integration qualities along the Gatineau River;

WHEREAS the Municipality wishes to acquire lot 5 497 608 to support its public infrastructure project, namely a public boat launch and the installation of a public dock:

WHEREAS the offer to purchase lot 5,497,608 and the delays between the Commission de protection du territoire agricole du Québec and the municipality have resulted in costs to the municipality;

WHEREAS lot 5 497 608 is owned by WYNDHAM OGONCZYK TOPOLSKI ALEXANDRA bearing roll number F_4192_89_4168.00_0000;

WHEREAS article 1097 of the Municipal Code of Québec, chapter C-27.1

1097. Every municipality may, in conformity with the expropriation procedure established by law,

3° expropriate any immovable, part of an immovable or servitude it needs for municipal purposes, including the parking of motor vehicles;

WHEREAS Section 4 of the Municipal Powers Act, Chapter C-47.1

- **4.** In addition to the areas of jurisdiction conferred on it by other Acts, a local municipality has jurisdiction in the following fields:
- (1) culture, recreation, community activities and parks;

THEREFORE, IT IS PROPOSED by Sylvain La France, **SECONDED** by Damien Lafrenière and resolved

TO authorize the Director General to proceed with the expropriation of lot number 5 497 608 located on chemin du Village Aylwin to allow the municipality to become the owner of this lot along the Gatineau River.

To authorize the Director General to mandate a land surveyor to prepare a plan and technical description for lot 5 497 608 in the cadastre of Quebec, a chartered appraiser to determine the value concerned and to mandate our attorney Rino Soucy of the firm DHC avocats for the legal proceedings related to this expropriation.
