BY-LAW 2022-044

MODIFYING BY-LAW 2021-037 RESPECTING SPEED LIMITS

WHEREAS paragraph 4 of the first paragraph of Article 626 of the Highway Safety Code (RSQ, c C-24.2.) Allows a municipality to make regulations prescribing the minimum or maximum speed of road vehicles in its territory;

WHEREAS a notice of motion has been given and a draft By-law has been tabled and presented at the sitting of September 6, 2022;

THEREFORE, **IT IS PROPOSED** by Paul Chamberlain, **SECONDED** by Matthew Orlando and unanimously resolved:

The By-Law number **2022-044** is adopted and that, accordingly, the Council enacted:

ARTICLE 1

That this By-Law is titled BY-LAW RESPECTING SPEED LIMITS.

ARTICLE 2

No one may drive a road vehicle at a speed:

a) Exceeding 30 km / h in school zones, where the regulatory signaling indicates this;

b) Exceeding 30 km / h on the following roads:

LAC DANFORD WEST ROAD From civic number 51 for a distance of .4 kilometers to civic number 79.

c) Exceeding 40 km / h and 70 km / h on the following roads:

RANGE 8 ROAD - From Route 105 is 40 KM for a distance of 1.3 km and a speed limit of 70 KM for a distance of 5.8 km and 40 KM for a distance of 1.5 km,

From Route 301 speed limit of 40 KM for a distance of 1.5 km, a speed limit of 70 KM for a distance of 5.8 km and a speed limit of 40 KM for a distance of 1.3 km.

d) Exceeding 40 km / h on the following roads:

LAMOUREUX ROAD, both ways from Route 301 a speed limit of 40KM for a distance of 1 km

WILLOUGHBY ROAD both ways from Route 105 and a speed limit of 40KM for a distance of 1.34 km

ANDERSON ROAD, both ways from Route 301 a speed limit of 40KM for a distance of 0.67 km

DESORMEAUX ROAD, both ways from Route 301 a speed limit of 40KM for a distance of 0.43 km

GAGNON ROAD, both ways from Desormeaux Road a speed limit of 40KM for a distance of 0.69 km

 ${\rm DORION}\ {\rm ROAD},$ both ways from Desormeaux Road a speed limit of 40KM for a distance of 0.69 km

2022-10-224 ST_PIERRE ROAD, both ways fron Bgley road a speed limit fo 40KM for a distance of 0.62KM

ARTICLE 3

Appropriate signage will be installed by the road department of the Municipality of Kazabazua

ARTICLE 4

Whoever contravenes article 2 of this By-Law commits an offense and is liable to a fine under section 516 or 516.1 of the Highway Safety Code.

ARTICLE 5

This By-Law rescinds all previous By-laws and comes into force in accordance with the Law.
