SUPPORT TO RESOLUTION 2021-R-AG135 REQUEST TO THE GOVERNMENT OF QUEBEC - REVISION OF BILL 88 « THE LAW AMENDING THE WILDLIFE CONSERVATION AND DEVELOPMENT ACT AND OTHER LEGISLATION »

WHEREAS Bill 88 « The Wildlife Conservation and Development Act and other legislation » introduced in the National Assembly by the Minister of Forests, Wildlife and Parks;

WHEREAS this bill would amend certain provisions concerning the tightening of the rules concerning, among other things, the consumption of alcohol during the

hunting period, stipulating that « no one may consume alcoholic beverages while hunting »;

WHEREAS the claims made by many associations (federation of outfitters, hunters' associations) with respect to this proposed amendment, which can be interpreted and raises many questions;

WHEREAS the Council of the MRC of La Vallée-de-la-Gatineau presumes that the current provision of the Act, prohibiting hunting under the influence of alcoholic beverages, must meet the government's objectives in this regard, which wished to add, to the existing provisions, the prohibition on the use of drugs following the legalization of cannabis;

WHEREAS hunting in many parts of Quebec is a sport and leisure activity, often during the holidays, and that hunters who consume alcohol must do so responsibly and in accordance with applicable laws and regulations.

THEREFORE, it is proposed by Sylvain La France, Seconded by Craig Gabie, and unanimously resolved by the council of the municipality of Kazabazua support the request by Resolution 2021-R-AG135 to ask the Quebec government to review Bill 88 « The Wildlife Conservation and Development Amendment Act and other legislation » and to amend section 33 of the current « Wildlife Conservation and Development Act » to introduce only the prohibition on hunting under the influence of drugs. , without completely prohibiting the consumption of alcohol during hunting.

It is also resolved to send a copy of this resolution to the local municipalities of the MRC of La Vallée-de-la-Gatineau for support, as well as to Mr. Robert Bussière, Member of Parliament for Gatineau.

SUPPORT TO RESOLUTION 2021-R-AG148 THAT SUPPORT THE MARIA-CHAPDELAINE MRC - REQUEST TO DECENTRALIZE QUEBEC'S HEALTH CARE SYSTEM TO PROMOTE LOCAL GOVERNANCE

WHEREAS Resolution 62-03-21 adopted by the Maria-Chapdelaine MRC Council in support of the recommendations made by the Quebec Physicians' Association for the decentralization of health care;

WHEREAS the centralization of Quebec's health and social services system, resulting from the 2015 reform sponsored by the then Minister, Dr. Gaétan Barrette, deprived the regions of the autonomy necessary to adequately meet the needs and priorities of the region;

WHEREAS this centralization of powers has led to a disconnect between decision-making centers and the places where services are provided;

WHEREAS the current administrative burden is an obstacle to the efficiency of the delivery of health and social services in the regions;

WHEREAS the lack of local governance and leadership deprives institutions of the autonomy essential to the administration of care tailored to their clients, according to their own needs and characteristics;

WHEREAS local institutions do not have the budgetary autonomy to self-manage in the control of the particular realities of their environment;

WHEREAS local labor organizations and different employees wish, through decentralization, to participate and be involved in decisions based on the real needs of health and social services staff as well as users;

WHEREAS the elected representatives of the municipalities of the regions are witnessing the consequences of this centralization;

WHEREAS 750 doctors from all regions of Quebec have mobilized under the name « Quebec Group of Physicians for the Decentralization of Health Care », which call for the decentralization of the health system;

WHEREAS the said 750 physicians issued 4 low-cost, simple and quick recommendations that were forwarded to the Minister of Health and Social Services this summer, namely:

• The re-establishment of a local decision-making administrator position for each hospital care center;

- The re-establishment of a position of local Director of Professional Services (PSD) for each hospital;
- The re-establishment of a local Council of Physicians, Dentists and Pharmacists (CMDP) for each hospital; and
- The re-establishment of a local Chiefs' Table bringing together all the department heads of a hospital;

WHEREAS the efforts of several organizations and actors in this regard are aimed at laying the foundations for strong and efficient local governance that will provide access to all basic medical care in the region without discrimination;

WHEREAS the management of the current health crisis (COVID-19 pandemic) requires flexibility and responsiveness that is lacking in the current decentralized health system;

WHEREAS all remote regions in Quebec are hard hit by the centralization of health care and social services;

WHEREAS numerous requests and resolutions made to the Government of Quebec and the Outaouais CISSS by the Council of the MRC of La Vallée-de-la-Gatineau since 2015 regarding this centralization of health care and social services in urban areas;

WHEREAS despite some corrections made following the tabling of the «
Observation Report on the Integrated Health and Social Services Centre of
Outaouais » by MSSS agent Sylvain Gagnon in January 2019, many shortcomings
and difficulties are still being identified;

WHEREAS recommendation of the MRC Planning and Development Committee at the April 6, 2021 meeting on this issue.

THEREFORE, it is proposed by Craig Gabie, seconded by Sylvain La France and unanimously resolved by the council of the municipality of Kazabazua to support resolution 2021-R-AG135 that supports the resolution 62-03-21 adopted by the Council of the Maria-Chapdelaine MRC, in support of the 4 recommendations issued by the Quebec Physicians' Association for the decentralization of health care and to call for a decentralization of Quebec's health care system in order to promote local governance.
