ADOPTION OF BY-LAW 2021-032 « AMENDING THE CONTRACTUAL MANAGEMENT BY-LAW 2018-022 »

CANADA PROVINCE OF QUÉBEC MRC VALLÉE-DE-LA-GATINEAU MUNICIPALITY OF KAZABAZUA

BY-LAW NUMBER 2021-032 AMENDING THE CONTRACTUAL MANAGEMENT BY-LAW 2018-022

WHEREAS the By-law number 2018-022 on Contractual Management has been adopted by the Municipality of Kazabazua on January 22, 2019 under section 938.1.2 of the Quebec Municipal Code ('C.M.');

WHEREAS the Act establishing a new development regime on lake and stream flood zones, temporarily granting municipalities powers to meet certain needs and amending various provisions (L.Q. 2021, Chapter 7) was sanctioned on March 25, 2021.

WHEREAS in the context of the COVID-19 pandemic, section 124 of the Act provides that for a period of three (3) years, effective June 25, 2021, municipalities will have to provide measures to favor Quebec businesses for any contract that involves an expenditure below the threshold for the expenditure of a contract that can only be awarded after a public tender;

WHEREAS a notice of motion was issued and a draft By-law was tabled and presented at the May 4^{th} , 2021 meeting.

IT IS PROPOSED BY: SYLVAIN LA FRANCE

SECONDED BY: CRAIG GABIE

AND UNANIMOUSLY RESOLVED THAT THIS BY-LAW BE ADOPTED AND THAT IT BE ORDERED AND DECREET AS FOLLOWS:

- 1. Section 2 of this By-law is effective from June 25, 2021, or the day this By-law comes into effect, according to the latest of these two dates, and remains so until June 25, 2024.
- **2.** The By-law number 2018-022 on CONTRACTUAL MANAGEMENT is modified by the addition of the following article:
- 10.1 Without limiting the principles and measures set out in this By-law for supplier rotation, in the context of the awarding of any contract that involves an expenditure below the threshold of the contract expenditure that can only be awarded after a request for public tenders, the municipality must favor Quebec goods and services as well as suppliers, insurers and contractors with a facility in Quebec.

An establishment in Quebec, within the meaning of this section, is any place where a supplier, insurer or contractor operates permanently that is clearly identified in its name and accessible during normal business hours.

Quebec goods and services are goods and services, the majority of which are designed, manufactured, assembled or realized, mostly from an establishment located in Quebec

The Municipality, in making a decision on the awarding of a contract covered by this article, considers in particular the principles and measures set out in terms of the rotation of potential suppliers and more specifically detailed to the articles 10 of the By-law.

3. This By-law comes into force in accordance with the law.

BILINGUAL STATUS - PROJECT BILL 14

WHEREAS the Charter of the French Language ("Charter") was adopted by the Quebec National Assembly in 1977, and over 80 municipalities throughout the Province of Quebec were recognized as having "bilingual status" pursuant to the provisions of Section 29.1 of the Charter;

WHEREAS the original provisions of the Charter allowed those municipalities that had a majority of residents who spoke a language other than French to be officially recognized under Section 29.1 of the Charter;

WHEREAS the Municipality of Kazabazua has been recognized as having bilingual status under Section 29.1 of the Charter since 1977 and wishes to retain such "bilingual status";

WHEREAS currently the Charter does not allow the recognition of "bilingual status" under Section 29.1 to be removed from a municipality or borough except at the request of such municipality or borough;

WHEREAS the Quebec National Assembly adopted Bill 170 imposing forced municipal mergers on municipalities in 2000 and simultaneously adopted companion legislation Bill 171 which drastically changed the criteria to obtain recognition under Section 29.1 of the Charter, from a majority of residents of a municipality or borough who spoke a language other than French to a majority of residents whose mother tongue was English;

WHEREAS the revised criteria under Bill 171 was imposed without consultation with municipalities recognized under Section 29.1 and adopted the narrowest and most inaccurate definition of the English-speaking communities within said municipalities or boroughs; and

WHEREAS the Charter of the French Language leaves it to municipalities with bilingual status to determine if they ever wanted to abandon bilingual status and none ever has, and in 2013 when the Parti Québécois sought to revise the rules to remove this power from municipalities, the Coalition Avenir Quebec and Quebec Liberal Party made it clear that it should be up to municipalities and not the Quebec Government to determine if this status should ever be relinquished;

WHEREAS the Municipality of Kazabazua is concerned by recent comments from Quebec's Minister Responsible for the French Language who stated he is considering changes to the Charter of the French Language related to bilingual status of municipalities which could put bilingual status of municipalities like Kazabazua in danger irrespective of the fact that in the 2016 census 49.3 % of the population declared that English was their first official language spoken;

THEREFORE, it was moved by Sylvain La France, Seconded by Henri Chamberlain and unanimously resolved

THAT the Municipality of Kazabazua hereby declares that it wishes to retain its "bilingual status" recognition under Section 29.1 of the Charter now and in the future as was guaranteed when given that right when the Charter was adopted in 1977;

THAT the residents and Council of the Municipality of Kazabazua view the recognition of our municipality under Section 29.1 as fundamental to the character of the municipality and as a testament of the historical presence of the both English and French speaking citizens in the municipality;

THAT the Municipality of Kazabazua vigorously opposes the proposed modifications to Section 29.1 of the Charter set out in Bill 14 and demands that the Quebec National Assembly continues to recognize the acquired rights of all municipalities and boroughs that currently possess such status and refrain from adopting any legislation that allows Section 29.1 recognition of bilingual status to be removed from a

municipality or borough except at the initiative of and express request of said municipality or borough;

THAT the Municipality of Kazabazua mandates the Director General to send copies of this resolution to all of members of the Quebec National Assembly, to all other municipalities in Quebec officially recognized under Section 29.1 of the Charter and to the local federal member of Parliament and the Commissioner of Official Languages of Canada as well as the Municipal Union of Quebec (UMQ), Fédération Québécoise des Municipalities (FQM) and the Federation of Canadian Municipalities (FCM).

CONSIDERING that the Chief Electoral Officer enacted, in accordance with section 3 of the Act to facilitate the conduct of the municipal general election of November 7, 2021 in the context of the COVID-19 pandemic (L.Q. 2021, c. 8), the Regulations amending certain municipal provisions to facilitate the conduct of the municipal general election of November 7, 2021 in the context of the COVID-19 pandemic ((2021) 153 G.O.Q. II , 2111B), which came into force on May 15, 2021 and amends, among other things, certain provisions of the Municipal Elections and Referendums Act (RLRQ, c. E-2.2) and the Mail Voting Regulations (RLRQ, c. E-2.2, r. 3) (below: the DGE Regulations);

CONSIDERING that under the second paragraph of section 659.4 of the Municipal Elections and Referendums Act, as amended by section 40 of the DGE Regulations, the municipality may adopt a resolution to allow anyone who is registered as a voter on his or her electoral roll and who is 70 years of age or older on the day set for the vote to exercise his or her right to vote by mail. , if such a person requests it;

CONSIDERING that the legal and regulatory framework for administering this voting method is now set and in force;

CONSIDERING that under the third and fourth paragraphs of section 659.4 of the Municipal Elections and Referendums Act, as amended by section 40 of the DGE Regulations, a resolution must be made by July 1, 2021 and a authenticated copy of the Act must be sent, as soon as possible after its adoption, the Minister of Municipal Affairs and Housing and the Chief Electoral Officer.
