TEMPORARY LOAN AS PART OF THE FINANCIAL ASSISTANCE PROGRAM PAID IN CASH, TECQ 2019-2023

WHEREAS under article 1093 of the Municipal Code, a municipality « may order by resolution temporary loans for the payment of current administrative expenses or expenses for which the payment of a subsidy by the Government or one of its ministers or bodies is assured and contract them on the conditions and for the period of time it determines ».;

WHEREAS the confirmation of the ministry of transportation grant dated June 9, 2022, to allow paving work on Begley Road, Brundtland Road, Chamberlain Road, Anderson Road, St-Pierre Street and Part of Range 8 Road;

WHEREAS under the TECQ 2019-2023, for municipalities with fewer than 2,500 inhabitants, the Government of Québec's contribution is paid in cash in five annual instalments and the Federal government's contribution is paid in cash in the same manner;

WHEREAS when a municipality quickly carries out the work provided for in its work program approved by the Department, and wants to meet its cash flow need while waiting to receive future contribution payments;

THEREFORE, IT IS PROPOSED by Sylvain La France, **SECONDED** by Paul Chamberlain and is resolved that:

THAT in order to fully finance the amounts provided for in the grant from the Ministère du Transport du Québec under the TECQ 2019-2023 program, the council is authorized to spend the sum of \$ 784,847. To obtain the sum, the municipality is authorized to borrow up to the amount of the said sum;

THAT the municipality will reimburse the capital amounts of the contribution received by the Government of Quebec and the Federal Government only to carry out the work planned in its programming of the TECQ 2019-2023 of the work approved by the Ministry, and that it wants to fill its need for liquidity while waiting to receive the future subsidy payments, and during the term of the temporary loan and interest expenses:

SUPPORT FOR THE APPLICATION TO THE MINISTÈRE DE LA SANTÉ ET DES SERVICES SOCIAUX (MSSS) – RESOURCES ALLOCATED TO PRE-HOSPITAL COVERAGE IN THE OUTAOUAIS Whereas the requests made by the Coopérative des paramédics de l'Outaouais (CPO) to the CISSS de l'Outaouais and the MSSS over the past year, whether to ensure complete coverage of the Outaouais region or in relation to the problem of retention of stretchers in hospitals;

Whereas despite the meetings held and the monthly follow-ups carried out via the SPU operational meetings with the MSSS, they do not report to us the recommendations made to the Conseil du trésor regarding the addition of hours of service, preventing any forecast of additional human resources by the CPO;

Whereas an announcement of a change in hours of service has been filed by the Director of Pre-Hospital Services of the MSSS without consultation with stakeholders, which leads to a reduction in hours of service to the population;

Whereas this reduction in hours of service of great impact on the deployment of human resources and the services rendered;

Whereas although the other regions of Quebec would not have been consulted either in relation to the MSSS decision, the Outaouais' requests should have been heard and considered since we have a particular situation, the CPO being the only ambulance company in the Outaouais and we have only one CISSS and CCSO;

Whereas alternative solutions would have been presented by the CISSS de l'Outaouais to the SPU Directorate of the MSSS in recent weeks, but that these would not have been retained in the proposal sent by the MSSS;

Whereas the CPO has also been making representations to the MSSS for more than a year to prevent a shortage of staff through a pilot project which, due to the lease bordering the Outaouais with Ontario, would have made it possible to hire Ontario students, but that this project would have been refused by the MEES;

Whereas the request to convert the MSSS faction schedules has as a schedule the month of March 2023 and the CEGEP students finish in May of the same year, so it will be difficult to be able to add human resources in the meantime, because the December 2022 cohort is composed only of students from regions other than the Outaouais and they are returning to their region of origin;

Whereas the special status granted to the Outaouais by the House of Commons in October 2019 in terms of, among other things, health and education, which allows for special funding for our region and accommodation measures;

Whereas the presentation of the file made by the CPO to the Conference of Prefects of the Outaouais on June 20, 2022 in this file;

Therefore, it is proposed by Matthew Orlando, **seconded** by Paul Chamberlain and resolved;

That the council of the municipality of Kazabazua support the resolution of the MRCVG to reiterate the requests made by the Coopérative des paramédics de l'Outaouais to the Ministère de la Santé et des Services sociaux concerning the requests for additional hours of service submitted, to ensure complete coverage of the Outaouais region and with regard to the problem of retention of stretchers in hospitals,

It is also resolved to send a copy of this resolution to Mr. Christian Dubé, Minister of Health and Social Services, Mr. Mathieu Lacombe, Minister responsible for the Outaouais and to all the Members of Parliament for the Outaouais.
