WHEREAS section 46.0.5 of the Environment Quality Act (RLRQ, chapter Q-2 hereinafter referred to as « the LQE »), the issuance of the authorization requested is subject to the payment of a financial contribution;

WHEREAS the Regulation mainly amending the Regulation respecting compensation for damage to wetlands and bodies of water (RCAMHH) and other regulatory provisions came into force on December 31, 2021;

WHEREAS, in accordance with section 10 of the RCAMHH, the nature of the project makes it possible to request the replacement of the payment of the financial contribution, in whole or in part, by the carrying out of work aimed at restoring or creating wetlands or bodies of water;

WHEREAS we must notify our intention to carry out replacement work within 30 days of receipt of the notice, received on January 23, 2023;

SUPPORT TO RESOLUTION 2022-R-AG231- REQUEST TO THE MINISTÈRE DE LA SANTÉ ET DES SERVICES SOCIAUX (MSSS) – RESOURCES ALLOCATED TO PRE-HOSPITAL COVERAGE IN THE OUTAOUAIS REGION

WHEREAS and following Resolution 2022-R-AG231 adopted by the MRCVG Council on June 21. 2022:

WHEREAS the requests made by the Coopérative des paramédics de l'Outaouais (CPO) to the CISSS de l'Outaouais and the MSSS over the past year, whether to ensure complete coverage of the Outaouais region or in relation to the problem of detention of stretchers in hospitals;

WHEREAS the meetings held and the monthly follow-ups carried out through the SPU operational meetings with the MSSS and that the recommendations made jointly with the CISSSO to the MSSS still do not allow solutions granting the addition of permanent resources to the Coopérative des paramédics de l'Outaouais;

WHEREAS a change in hours of service was made on October 31, 2022 by the Director of Pre-Hospital Services of the MSSS without consulting stakeholders, resulting in a decrease in hours of service to the population and that a quarterly evaluation illustrating the effectiveness of the changes made to pre-hospital coverage in the Outaouais must be carried out;

WHEREAS alternative solutions have been presented by the CPO to the CISSS de l'Outaouais in recent weeks, but that these would not have been retained (non-detention projects and rapid release of stretchers);

WHEREAS the special status granted to the Outaouais by the House of Commons in October 2019 in terms of, among other things, health and education, which allows for specific funding for our region and accommodation measures;

WHEREAS the presentation of the file made by the CPO to the Conférence des préfets de l'Outaouais on June 20, 2022 in this file and the update of it made on December 13, 2022 to the MRCVG Council;

THEREFORE, IT IS PROPOSED by Matthew Orlando, **SECONDED** by Sylvain La France and unanimously resolved by the members present of the municipality of Kazabazua;

TO support this resolution, which reiterates the requests made by the Coopérative des paramédics de l'Outaouais to the Ministère de la Santé et des Services sociaux concerning requests for additional hours of service submitted to ensure complete coverage of the Outaouais region and with regard to the problem of holding stretchers in hospitals.

It is also resolved to support the request to the CISSSO to obtain a quarterly calendar of the situation and an action plan resulting from the findings of the quarterly evaluation that the needs in the Outaouais territory are being met;

Be it also resolved to support the transmission of a copy of this resolution to Mr. Christian Dubé, Minister of Health and Social Services, Mr. Mathieu Lacombe, Minister responsible for the Outaouais and all the Members for the Outaouais;

It is also resolved to support the transmission of a copy of this resolution to the local municipalities of the MRC de La Vallée-de-la-Gatineau and the MRC de l'Outaouais, for support, and to authorize Ms. Chantal Lamarche, Warden, to carry out all the steps relating to this file.
