BY-LAW 2023-047 MODIFYING BY-LAW NUMBER 2023-045 IMPOSING THE RATES OF TAXES FOR THE FISCAL YEAR 2023

WHEREAS the council of the municipality of Kazabazua adopted by-law 2023-045 respecting the imposition the rates of taxes for fiscal year 2023 dated January 10, 2023 and entered into force on January 11, 2023;

 2^{o} the second payment, ninety (90) days after the first payment, 33% of the total amount, due on July $1^{st}\!,\,2023,$

 3^o the third payment, sixty (60) days after the second payment, 33% of the total amount, due date September 1st, 2023; »

OFFER TO PURCHASE LOT NUMBER 5 496 961

GROUP INSURANCE CONTRACT - GROUP PURCHASE - UMQ REGROUPEMENT QUÉBEC-BEAUCE-PORTNEUF-MAURICIE-LAURENTIDES-OUTAOUAIS SOLUTION – JANUARY 1ST, 2024 TO DECEMBER 31ST, 2028

WHEREAS in accordance with the Cities Act / the Municipal Code and the UMQ Solution, the municipality of Kazabazua and this council wish to authorize the launch of a public call for tenders to obtain group insurance products for its employees and, where applicable, for its elected officials, for the period from January 1, 2024 to December 31, 2028;

WHEREAS Mallette actuaires inc. has already been awarded, following a public call for tenders, for the independent consulting services required by the Union des municipalités du Québec (UMQ) in the application of the UMQ Solution;

WHEREAS the remuneration provided for in the contract – Solution UMQ – to be granted is 0.65% to the consultant Mallette actuaires Inc. and the management fees provided for the UMQ are 1.15%;

WHEREAS the municipality of Kazabazua now wishes to confirm its adherence to the UMQ's group insurance consolidation solution and mandate it to Mallette actuaires inc. accordingly;

IT IS PROPOSED by Craig Gabie SECONDED by Sylvain La France And resolved

THAT the preamble is an integral part hereof as if recited at length;

THAT this Council hereby confirms its adherence to the UMQ Solution for group insurance for its employees and/or elected officials, at the choice of the municipality;

THAT membership in the group - Solution UMQ - will be for a maximum of five years, i.e. for the duration of January 1, 2024 to December 31, 2028;

THAT the municipality of Kazabazua mandate the UMQ to act as mandatary to represent it on the group insurance contract to be granted following the application of these terms and conditions and its renewal, as well as for access to its group insurance file with the insurer, in compliance with the rules of protection of personal information;

THAT the Municipality of Kazabazua undertakes to pay the UMQ a management fee of 1.15% of the total premiums paid by the Municipality of Kazabazua during the contract and a remuneration of 0.65% of the total premiums paid by the Municipality to the consultant Mallette actuaires Inc., whose mandate obtained for the consolidation is also attached by the Municipality of Kazabazua, following a public call for tenders;

THAT the municipality of Kazabazua undertakes to respect the terms and conditions of the contract to intervene with the insurance company to which the contract will be granted as a result of the application of these terms and conditions as well as the conditions of the consultant's mandate.

REQUEST FOR BILINGUAL MUNICIPALITIES TO JOIN THE CITY OF CÔTE SAINT-LUC AS CO-PLAINTIFFS IN CHALLENGING LAW 96 BEFORE THE COURTS - LETTER OF INTENT

WHEREAS since the announcement made by the Quebec Government regarding the adoption of the *Act respecting French, the official and common language of Quebec ("Law 96"),* the City has serious apprehensions of the impact this legislation would have on the linguistic rights of its residents;

WHEREAS despite the City's recognized bilingual status, similar to the other municipalities throughout Québec, there are several provisions of Law 96 that will come into effect in June 2023, dealing specifically with municipalities of bilingual status, that will negatively impact all concerned municipalities' means of functioning and servicing the public interest of its residents;

WHEREAS not only does Law 96 compromise the concerned municipalities' bilingual status, which is intrinsically part of their cultural identity, but the proposed provisions also extend far beyond language rights and undermine constitutionally protected and inalienable rights that belong to all Quebec citizens;

WHEREAS the City deems the following legal provisions ("Articles") completely egregious and infringing on the concerned municipalities' rights:

- Art. 6, 14 of Law 96, adding art. 13.1-13.2, and 21.1-21.12 of the Charter: The provisions that prohibit municipalities from contracting in a language other than French or providing services in English, unless it's contracting with a person/entity residing outside of Quebec, without regard to the exceptions provided by the law.
- Art. 96 of Law 96, adding art. 152.1: The provision prohibits even Bilingual status municipalities from awarding a contract to companies with 50 employees or more who are not compliant with OQLF's requirement of having a valid francization certificate.
- Art. 111, 114, 115 and 116 of Law 96 replacing art. 166, 174, 175, of the Charter respectively: The provisions that allow the Office Quebecois de la langue française ("OQLF") to inspect and seize at any time without prior notice, documents or equipment belonging to any municipal body for compliance purposes without a warrant.
- Article 117 of Law 96 adding art. 204.31 of the Charter: The provision allowing the Minister of the French Language ("Minister") to withhold government grants if the municipality does not comply with any provision of Law 96.
- Art. 117 of Law 96 adding art. 204.32 of the Charter: The provision requiring administrative bodies to implement disciplinary measures for employees who do not comply with the linguistic obligations of Law 96.

WHEREAS the City requested a quote from several law firms detailing the estimated total cost of the mandate to analyse and contest the above-stated Articles;

WHEREAS on October 11, 2022, the City accepted the proposal transmitted by Grey Casgrain s.e.n.c, a well-respected law firm represented by Me Julius Grey, specializing in constitutional law;

IN VIEW OF THE ABOVE, IT IS PROPOSED by Sylvain La France, **SECONDED** by Craig Gabie and resolved;

THAT the municipality of Kazabazua agrees to:

- join with the City as a co-plaintiff in contesting the above-mentioned Articles of Law 96, including the filing of a <u>stay of proceedings</u>, where appropriate, and in the eventual contestation on the merits in order to avoid the detrimental and financial effects that Law 96 will have on the Bilingual Municipalities;
- share the legal fees and costs with the City and other co-plaintiffs, on a pro rata basis, based on the relative size of the population of each of the coplaintiffs, said fees to be invoiced and paid in a timely fashion;
- 3. sign a mandate with the Law Firm of Grey Casgrain s.e.n.c. to allow them to represent said Bilingual Municipality in the above-mentioned proceeding;
- 4. recognise that for the purpose of efficiency and cohesion in this matter, the City of Cote Saint-Luc will be the representative of all co-plaintiffs in communications and instructions with Grey Casgrain s.e.n.c.

THAT the municipality of Kazabazua mandates the Mayor, Mr. Robert Bergeron duly authorized representative for the signature of the letter of intent, which takes effect on the date of signature;
