2015-02-39 Award of contract to the Municipal Engineering Service MRCVG

Whereas resolution 2014-R-AG412 adopted by the Council of the MRCVG asking the MAMOT revise its position on refusing reimbursement of professional fees of municipal engineering services as eligible expenditures by local municipalities in the program TECQ 2014 -2018;

Whereas MRCVG is still waiting for a response from MAMOT on this application, but some follow-ups obtained predicts and leaves the possibilities of a continued refusal, especially because of federal clauses (Excise Tax);

Whereas the excellent services rendered by the Municipal Engineering Service of the MRCVG at lower cost than those offered by private engineering firms;

Whereas the proximity of engineers and technicians working in municipal engineering service, their availability and the savings on travel costs;

Whereas the desire to ensure the continuity, consolidation and the survival of the service in the region;

Whereas the municipalities that would grant warrants to the municipal engineering department of the MRC, despite the non-payment by the TECQ could do so even their municipal budget;

Whereas that the money not used in the TECQ could be used for other purposes by municipalities, especially for expenses related directly to the execution of works:

Whereas the proceeds from the TECQ assigned for other purposes, added to those required for the award of the contract to the Municipal Engineering Department, may be equivalent to the total amount budgeted by municipalities for the mandates provided to municipal immobilization;

Whereas the resolution 2015-R-AG018 adopted by the Council of the MRCVG asking local municipalities to confirm their intention to continue granting to the municipal engineering service, regardless of the outcome of the application to the MAMOT for eligibility of expenditures of the municipal engineering services for the TECQ, and this in order to ensure sustainability, the consolidation and survival of this service offered in the regions.

Consequently, it was moved by councilor Pamela Lachapelle, seconded by councilor Michel Collin, and it was resolved that the Council of the Municipality of Kazabazua informs the MRC of its intention to continue granting mandates to municipal engineering service, regardless of the issue of the application to MAMOT for eligibility of expenditure of municipal engineering services to TECQ, and in order to ensure the survival, consolidation and the survival of the service offered in the region.

2015-02-42 Intervention of the Fire Service on the municipal territory

WHEREAS the fire department of the Municipality of Kazabazua is on the scene of an accident with injuries on the territory of the

Municipality of Kazabazua before the arrival of the SQ or

ambulance;

WHEREAS the fire department may deem necessary for the assistance;

WHEREAS ambulance or S.Q. automatically cancels the fire department for

assistance;

THEREFORE it was moved by Councillor Pamela Lachapelle, seconded by councilor Kevin Molyneaux and unanimously resolved that the Municipality of Kazabazua notify the 911 call center, that once the initial call received for the decarceration service of the municipality Kazabazua in the territory of the Municipality of Kazabazua according to the five (5) requirements established by the CLR Group, it could be triggered at the same time as the call for the S.Q. (Quebec Provincial Police) and the ambulance service and that the parties will elaborate on the necessity for the decarceration service of the Municipality of Kazabazua.

2015-02-43 Mandate to the fire services of the 4 municipalities of the south of the MRC Vallée-de-la-Gatineau

WHEREAS the MRC Vallée-de-la-Gatineau and municipalities have different

roles, but the MRCVG should gather, facilitate and ensure the compliance with the protective and implementation fire plans by

the municipalities throughout its territory.

WHEREAS the municipality must respect the actions to be taken in its local

implementation, all planned and mandatory actions of the safety cover plan of the MRCVG and implementation plan by the

Minister of Public Safety.

WHEREAS the management of fire services in the municipalities of

Denholm, Low, Kazabazua and Lac-Sainte-Marie, suggests exploring possible solutions to increase efficiency in the performance of their duties and responsibilities in accordance

with their local implementation plan.

THEREFORE it was moved by Councillor, Pamela Lachapelle, seconded by Councillor Kim Cuddihey-Peck and unanimously resolve to ask the four directions of the fire service to explore possible solutions in order to increase the effectiveness of fire safety cover plan by an amalgamation, merger or even the creation of an inter municipal board of management of the fire department for the 4 municipalities in the south of the MRC Vallée-de-la-Gatineau.

applicable taxes and that Eric Villeneuve after a year of service in the municipality will be allowed to follow the Firefighter training 1 and authorize the Director General to sign the contract with EducExpert.

2015-02-45 Funding Program for part-time or volunteer firefighter training

WHEREAS the Regulation respecting the conditions to exert within a municipal fire service provides training requirements for firefighters to ensure a minimum professional qualification;

WHEREAS this regulation is part of a desire to ensure municipalities forming fire crews with the skills and abilities necessary to respond effectively to emergencies;

WHEREAS in December 2014 the Quebec government established the Financial Assistance Program for the training of volunteers and part-time firefighters;

WHEREAS the program main objective is to provide municipal organizations financial assistance to enable them to have a sufficient number of trained firefighters to act effectively and safely in an emergency;

WHEREAS this program also aims to promote the acquisition of competences and basic skills required by part-time and volunteer firefighters practicing in municipal fire safety services;

WHEREAS the Municipality of Kazabazua wishes to benefit from the financial support offered by the program;

WHEREAS the Municipality of Kazabazua provides for the formation of six (6) firefighters during the next year to respond effectively and safely in emergency situations on its territory;

WHEREAS the municipality must send his application to the Department of Public Safety through the MRC of Vallée-de-la-Gatineau in accordance with Article 6 of the program.

It was moved by councilor Kevin Molyneaux, seconded by councilor Tanya Gabie and resolved to apply for financial aid under the financial Assistance Program for part-time or volunteer firefighter training at the Department of public Safety and forward the request to the MRC Vallée-de-la-Gatineau.

2015-02-46 Adoption of By-Law 2015-04 Speed limits

WHEREAS paragraph 4 of the first paragraph of Article 626 of the Highway

Safety Code (RSQ, c C-24.2.) Allows a municipality to make regulations prescribing the minimum or maximum speed of road

vehicles in its territory;

WHEREAS a notice of motion was given at a meeting of the Municipal

Council of the Municipality of Kazabazua. held on January 13, 2015 and entered in the minute book under number **2015-01-20**.

THEREFORE, it is proposed by councilor Michel Collin, Seconded by councilor Tanya Gabie **AND UNANIMOUSLY RESOLVED**:

The By-Law number **2015-04** is adopted and that, accordingly, the Council enacted:


ARTICLE 1

That this By-Law is titled BY-LAW RESPECTING SPEED LIMITS.

ARTICLE 2

No person shall drive a road vehicle at a speed:

- a) exceeding 40 km / h on roads as specified in Annex A;
- b) exceeding 70 km / h on roads as specified in Annex A.



ARTICLE 3

Appropriate signage will be installed by the road department of the Municipality of Kazabazua

ARTICLE 4

Whoever contravenes article 2 of this By-Law commits an offense and is liable to a fine under section 516 or 516.1 of the Highway Safety Code.

ARTICLE 5

This By-Law shall enter into force 90 days after its adoption, unless disallowance notice by the Minister of Transport published in the Gazette officielle du Québec.

This By-Law may be modified by resolution of Council for modification or addition to the list of roads in Annex A.
