### **ARTICLE 1**

That the Municipalité régionale de Comté de la Vallée-de-la-Gatineau and the municipalities of Aumond, Blue Sea, Bois Franc, Bouchette, Cayamant, Déléage, Denholm, Egan Sud, Gracefield, Grand Remous, Maniwaki, Messines, Montcerf-Lytton, and Sainte Thérèse de la Gatineau shall adopt a bylaw to join in the Agreement Delegating to the Municipalité régionale de Comté des Collines-de-l'Outaouais Competence to Establish and the Establishment of a Common Municipal Court and accepting the conditions integral to the Agreement.
