PROJECT BY- LAW NUMBER 03-2016

BY-LAW 03-2016 AMENDING BY-LAW NUMBER 2014-02 CONCERNING THE CODE OF ETHICS AND PROFESSIONNAL CONDUCT OF ELECTED OFFICIAL OF THE MUNICIPALITY OF KAZABAZUA

WHEREAS ethics the *Act on Ethics and professional conduct in municipal matters* (RLRQ c. E-15.1.0.1), requires local municipalities to adopt a code of ethics and professional conduct applicable to elected officials;

WHEREAS, pursuant to the Act, the Municipality adopted By-Law number 2014-02 on the Code of Ethics and Professional Conduct of elected officials of the Municipality of Kazabazua, which was revised in accordance with the Act for this purpose (hereinafter designated as « By-Law number 2014-02 »);

WHEREAS following the adoption of the Act to amend various legislative provisions concerning municipal affairs especially concerning political financing (L.Q. 2016, chapter 17), the municipality must modify the code of ethics and professional conduct applicable to elected officials;

WHEREAS a notice of motion has been previously given, pursuant to the Act, at the extra ordinary meeting of July 14, 2016 and that a project By-Law was filed by the council member giving the notice of motion, that a read request for exemption was requested and that each of the council members present acknowledges having received a copy of the project By-Law and declares to have read and waives its reading:

THEREFORE, IT IS PROPOSED by Tanya Gabie, **SECONDED** by Pamela Lachapelle and resolved:

THAT the municipal Council adopt this project By-Law number 03-2016 to amend By-Law number 2014-02, as follows:

ARTICLE 1 – PREAMBULE

The preamble of this By-Law forms an integral part.

ARTICLE 2 – TITLE

The title of this By-Law is: $^{\circ}$ By-Law No. 03-2016 amending By-Law No. 2014-02 on the Code of Ethics and Professional Conduct of elected officials of the Municipality of Kazabazua $^{\circ}$.

ARTICLE 3 – ADDITION

By-Law No. 2014-02 is amended by adding after Article 5.3.7, the following:

« 5.4 Political Financing and public announcement

It is prohibited for any member of the Council to make the announcement at a political fundraising event, realization of a project, the conclusion of a contract or a grant by the Municipality unless a final decision on this project, contract or grant has already been taken by the competent authority of the Municipality.

Council member firm that employs staff must ensure that its employees comply with the prohibition in the first paragraph. In case of non compliance with this prohibition by one of these, the Council member is attributable for the purposes of the imposition of sanctions under the Act. »



ARTICLE 4 - ENTRY INTO FORCE

This By-Law shall enter into force according to Law.

PROJECT BY-LAW NO. 04-2016

BY-LAW 04-2016 AMENDING BY-LAW NO. 06-2012 CONCERNING THE CODE OF ETHICS AND CONDUCT OF MUNICIPAL EMPLOYEES

WHEREAS the *Act on Ethics and professional conduct in municipal matters* (RLRQ c. E-15.1.0.1), creates the obligation for all local municipalities to adopt a code of ethics and professional conduct that sets out the main values of the Municipality on ethics and rules that should guide the conduct of the employees therein;

WHEREAS the Municipality adopted the By-Law No. 06-2012 on the Code of Ethics and Professional Conduct for municipal employees to comply with the Act (hereinafter designated as « By-Law No. 06-2012 »);

WHEREAS following the adoption of the Act to amend various legislative provisions concerning municipal affairs especially concerning political financing (L.Q. 2016, chapter 17), the municipality must amend the Code of Ethics of Municipal Employees;

WHEREAS a notice of motion has been previously given, pursuant to the Act, at the extra ordinary meeting held on 14 July 2016 that a read request for exemption was requested and that each of the council members present acknowledges having received copy of the draft By-Law and declares to have read and waives its reading;

WHEREAS the formalities prescribed in the Act have been met

THEREFORE, IT IS PROPOSED by Michel Collin, **SECONDED** by Pamela Lachapelle and resolved:

THAT the municipal Council adopt this project By-Law No. 04-2016 to amend the By-Law No. 06-2012, as follows:

ARTICLE 1 - PREAMBULE

The preamble of this By-Law forms an integral part.

ARTICLE 2 - TITLE

The title of this By-Law: « By-Law No. 04-2016 Amending By-Law No. 06-2012 on the Code of Ethics and Professional Conduct for municipal employees »

ARTICLE 3- ADDITION

By-Law No.06-2012 is modified by adding after section 5.6 the following:

« 5.7 - Financing policy and public announcement

It is prohibited for all employee, employed by the office of a council member, to make the announcement at a political fundraising event, realization of a project, the conclusion of a contract or a grant by the municipality, unless a final decision on this project, contract or grant has already been taken by the competent authority of the Municipality. »

ARTICLE 4 ENTRY INTO FORCE

This By-Law shall enter into force in accordance with the Law.
