# ADOPTION OF THE BY-LAW 2017-008 AMENDMENT TO BY-LAW 2017-005 IMPOSING THE RATES OF TAXES FOR THE FISCAL YEAR 2017

**WHEREAS** In order to cover the expenses of the purchase of a bin for domestic waste and the purchase of a bin for recycling, the Municipality must amend its bylaw number 2017-005 imposing the rates of taxes for the fiscal year 2017;

WHEREAS a notice of motion was previously given in accordance with the Act at the regular meeting held on February 7, 2017 and a draft by-law was tabled by the council member who gave the notice of motion, that a request for exemption from reading was requested and that each of the members of council present acknowledges having received a copy of the by-law and declares to have read it and renounces its reading;

**CONSEQUENTLY, IT IS MOVED** by Sandra Lacharirty, **SECONDED** by Michel Collin and resolved:

**THAT** the municipal Council adopt the present By-Law number 2017-008 to amend By-Law 2017-005 as follows:

## **ARTICLE 1 - PREAMBLE**

The preamble to this By-Law is an integral part of it.

#### **ARTICLE 2 - TITLE**

The title of this Regulation is: "By-law number 2017-008 amending By-law number 2017-005 imposing the rates of taxes for the fiscal year 2017;

#### **ARTICLE 3 - ADDITION**

By-Law No. 2017-005 is amended by adding after section 5 the following text:

« 5.1 In order to meet the cost of purchasing the bin for domestic waste and the bin for recycling, a compensation is imposed and levied for the fiscal year 2017 a fixed amount of \$ 19,25 for the domestic waste bin and a fixed amount for the recycling bin of \$ 19.25 on all units identified by code 1, 2, 3, 4, 5, 6, 7, 8, 9, 13, 16, 19, 20 and 21 of the territory of the municipality of Kazabazua »

### **ARTICLE 4 - ENTRY INTO FORCE**

This By-Law comes into force in accordance with the law.
