ADOPTION OF BY-LAW 2019-025 PERTAINING TO TARIFICATION FOR NON-MUNICIPAL RATEPAYERS FOR FIRE PROTECTION, RESCUE AND OTHER SERVICES PROVIDED BY THE KAZABAZUA FIRE PROTECTION SERVICE FOLLOWING A VEHICLE ACCIDENT ON THE ROAD AND OFF-ROAD

**WHEREAS** any municipality may provide that all or part of its goods, services or activities are funded through a tarification method under article 244.1 of the Act on municipal taxation;

**WHEREAS** this by-law does not affect the agreements of mutual provision of service in the fire protection between the municipalities in these agreements;

**WHEREAS** under article 4 of the « Municipal powers Act chapter C - 47.1 », that any local municipality has jurisdiction in the field of security and under this Act and to the extent provided, a local municipality adopts a by-law when it wants to make mandatory a rule of general and impersonal nature;

**WHEREAS** the council wishes to establish a rate when the fire protection or rescue services are required for vehicle rescue or fire, whose owner is not a ratepayer of the Municipality of Kazabazua or the Municipality of Alleyn-et-Cawood;

**WHEREAS** the municipality receives a fixed rate from the Société assurance automobile du Quebec (SAAQ) only if the fire protection service uses auto extrication « Jaws of Life » equipment;

**WHEREAS** there are times when the Jaws of Life service is called and the auto extrication equipment is not used, but other services are provided by the Fire Protection Service to protect the injured victim(s) and first responders, including first aid, vehicle fire extinction and traffic direction;

**WHEREAS** a notice of motion of this by-law has been given at a regular meeting of May 7, 2019 and that the draft by-law was tabled on the same date;

**CONSEQUENTLY, IT IS PROPOSED** by Henri Chamberlain, **SECONDED** by Craig Gabie and resolved;

THAT this by-law be adopted and that it be ordered and ruled as follows:

# **ARTICLE 1**

When the Fire Protection Service is called to intervene following a road accident, to provide services other than auto extrication (first aid, traffic direction, etc.) for a vehicle which is owned by a non-ratepayer of the Municipality of Kazabazua and the Municipality of Alleyn-et-Cawood, this will be subject to a rate of \$400.00 per hour for a minimum of three (3) hours per call, plus an administration fee equivalent to 15% of the total cost and if outside assistance is called this Bill be added to the invoice and this total is divisible by the total affected vehicle(s);

# **ARTICLE2**

These costs and administration fee are payable by the owner of the vehicle involved in the incident, when the owner of the vehicle is not a ratepayer of the Municipality of Kazabazua or the Municipality of Alleyn-et-Cawood.

# **ARTICLE3**

This By-law comes into force according to law.

**WHEREAS** the Mutuelle des Municipalité du Québec, which insures the risks of the Municipality of Kazabazua, encourages the implementation of the fire safety cover plan;

**FOR THESE REASONS, IT IS PROPOSED** by Henri Chamberlain, **SECONDED** by Craig Gabie and unanimously resolved by the members present

**THAT** the local municipality agrees to collaborate with the MRC so that the fire safety cover plan can be revised during the 6th year following the date of its coming into force or its last attestation.
