AFEAS – SUPPORT NATIONAL DAY FOR UN RECOGNIZED WORK

CONSIDERING that the AFEAS (Women's Association for Education and Social Action), made up of nearly 8,000 members, grouped in 203 Afeas in 11 regions of Quebec, has launched, in the fall of 2019, a campaign of mobilization across the province to make Publicly acknowledge the economic value of women's un recognized work;

CONSIDERING that National un recognized Work Day is an original Afeas activity that began in 2001 and is held annually on the first Tuesday in April;

CONSIDERING that in 2010, at the initiative of MP Nicole Demers, the House of Commons unanimously passed a motion creating National un recognized Worf Day, but the government of the day did not implement the motion;

CONSIDERING until the adoption of such a day, the Afeas continues its annual campaign to have this un recognized Work Day recognized by parents and caregivers;

CONSEQUENTLY, IT IS PROPOSED by Lynn Noël, **SECONDED** by Lynne Lachapelle and resolved,

THAT the Council of the Municipality of Kazabazua supports the afeas (Women's Association for Education and Social Action) approach to have the municipal authorities and the Quebec and Canadian governments come together to officially declare the first Tuesday in April « National un recognized Work Day »,

THAT a copy of this resolution be forwarded to the Afeas (Women's Association for Education and Social Action) in Gracefield.

2020-03-047 1.13 SUPPORT TO THE POSITION OF THE FÉDÉRATION QUÉBÉCOISE DES MUNICIPALITÉS – BILL NO 37 AND POLICY ON LOCAL PURCHASE

CONSIDERING that the Quebec government recently introduced Bill 37 to dissolve the Quebec Shared Services Centre (CSPQ) and the establishment of a Quebec Government Acquisition centre and Technology Infrastructure;

CONSIDERING that through this bill, the government plans to consolidate all Quebec government supplies into a single entity, including supplies from the health and social services network;

CONSIDERING that despite the spending reduction target that underpins the creation of this new body, the issue of centralization of purchases raises a great deal of concern about local purchasing, a tool essential to the economic vitality of Regions;

CONSIDERING that with its bill, the government is relying on volume discounts, without taking into account the impacts for Quebec regions;

CONSIDERING the position of the Federation of Quebec Municipalities (FQM) to remind the government of the negative consequences associated with the concentration of purchasing groups, for small and medium-sized enterprises located throughout the region, who will not have the production capacity to meet the required volumes and do business with the government;

CONSIDERING that the FQM believes that the implementation of such a consolidation project cannot be done without the prior adoption of a local procurement policy, which would stimulate economic activity in communities as well as Contribute to the development of the regions

CONSEQUENTLY, IT IS PROPOSED by Sylvain La France, **SECONDED** by Paul Chamberlain and resolved to propose that the Council of the Municipality of Kazabazua supports the position of the Federation of Quebec Municipalities on Bill 37 in order to call on the Quebec government to review this bill and to quickly adopt a local procurement policy for the public sector organizations.
